

**Bernedoodle Kennels Puppy Contract & Health Warranty  
(No Breeding Rights)**

Bernedoodle Kennels represents to our buyers that we are the legal owner of the puppy and we have full right and authority to sell the puppy. As the responsible buyer of this puppy, you agree to house the puppy indoors, take excellent care of the puppy, provide a loving home, good quality food, medical care and anything necessary to maintain a happy and healthy puppy. Bernedoodle Kennels will not be responsible for any veterinarian expenses pertaining to this puppy/dog once it has left our possession.

Bernedoodle Kennels reserves the right of the first two picks of the litter.

Bernedoodle Kennels will always take their precious cargo (puppy/dog) back if you are unable to care for him/her (but no refund will be given including shipping/transportation costs). Buyer has three business days (from the date they received the puppy) to take the puppy to a licensed veterinarian at their cost. If an illness or disease is found by the veterinarian that threatens the life of the puppy, the buyer will have seven days to return the puppy to Bernedoodle Kennels. A full refund of the purchase price of the puppy will be given.

Bernedoodle Kennels has the option of having the diagnosis confirmed by their Veterinarian before a refund will be issued. The following conditions are not covered under this health guarantee. Distemper, Parvo, Coccidia, Giardia, parasites and Rabies or any other communicable disease. Caution needs to be taken as to where you let your puppy roam until they have had all their vaccinations. A vets office is a good place to hang on to your puppy or keep in crate when you are in the waiting area as there have been sick animals in and out of their office and your puppy could easily contract diseases.

Bernedoodle Kennels provides a two year health warranty to the original purchaser from date of birth against Genetic/Hereditary defects that would cause euthanization of the dog or substantially interfere with the quality of life for the dog. This warranty will be provided upon written confirmation from the buyers licensed veterinarian, that the puppy has been, and is up to date on vaccinations (four complete rounds of vaccinations, yearly vaccinations and monthly heartworm) from the time of purchase for this puppy to the date of the diagnosis of Genetic/Hereditary defect, or this health warranty will be void. Improper bite or umbilical hernias are not covered as these conditions do not affect the quality of life and do not threaten the life of the dog.

Bernedoodle Kennels must be notified within 24 hours of a vets exam and provide us with a written confirmation from your licensed veterinarian explaining what/if a genetic defect was found. In the case that hip dysplasia is found, the buyer must provide Bernedoodle Kennels with x-rays of hips and copies of complete veterinarian history showing that the puppy/dog has been properly vaccinated from the date of this contract (four complete rounds of vaccinations), yearly vaccinations and monthly heartworm, The xrays will then be evaluated by our veterinarian. The defect/hip rating must be sufficient enough that it would require a hip replacement or would be debilitating to the dog. This health guarantee does not warrant hip issues that are caused by being overweight or is the result of an injury. Bernedoodle Kennels will not refund shipping or transportation costs.

Bernedoodle Kennels cannot guarantee color, size, or temperament once the puppy leaves our possession. It is suggested to wait until the dog is at least one year of age to do any repetitive or strenuous activities such as agility training etc. This is hard on large breed dogs hips and joints. Health issues caused by environmental factors such as allergies, autoimmune disorders, trauma, abuse, and failure to maintain the general health of the puppy/dog is not covered in this warranty.

The seller is available for any questions during the entire lifetime of the dog. Bernedoodle Kennels will give the puppy its first set of vaccinations DA2PP (distemper, Adenovirus Types 1 and 2, Parainfluenza, Parvovirus). This vaccine protects against respiratory and hepatitis viruses, as well as parvovirus. Parvo is a deadly intestinal virus that can affect adults. This vaccine should be given every year. The puppies will also be given worm medication. Back dew claws will be removed, and front dew claws will not be removed. Dew Claws can sometimes be stubborn and reappear as little bumps... if this happens they can be removed by your veterinarian at the buyers expense.

Bernedoodle Kennels requires your puppy to be spayed/neutered by the age of one year. It is the buyers responsibility to send Bernedoodle Kennels by way of USPS or email a copy of the spay/neuter documentation from the veterinarian that the procedure has been performed.

If Bernedoodle Kennels does not receive proof of spay/neuter within one year of age of the puppy from a licensed veterinarian this entire health warranty will be void. If the surgery is not done within one year from the date of birth, the buyer will be liable for \$250,000 for breeding rights and would void any warranty/health guarantee as stated in this contract. In the case that any legal action would need to be taken regarding this puppy, it will be taken up in the courts of Merrick County, Nebraska.

This health guarantee/contract is not transferable and only applies to the original buyers of this puppy. We will not release a puppy from our possession until we have your signed contract in hand.
